Rules: USEF rules will be following to biting, saddlery, and use of tie downs. Riders must wear hard hats and footwear with heels. In addition, vests must be worn by all riders on the cross-country course. **Coggins must be sent in or present upon arrival**

Horse Trial: 2018 USEF Dressage, Stadium, and Cross Country – \$95 each (circle division and note below)

1. Grasshopper – Intro Test B (jumps 12” logs)
2. Introductory – Intro Test C (jumps 2’ mostly logs on ground)
3. Starter – Beginner Novice Test A (jumps 2’3”, XC course logs on ground working to roll top, coops, and dog houses)
4. Beginner Novice – Beginner Novice Test B (jumps 2’7”)
5. Novice Level – Novice Test B (jumps 2’11”)
6. Training Level – Training Test B (jumps 3’3”)
7. Modified – Preliminary A (stadium jumps 3’7”; XC combination of training, modified, and preliminary)

Extra Dressage Tests: 2018 USEF Dressage, \$25 each (circle division and note below)

8. Intro A, B, or C 9. Beginner Novice A or B 10. Novice A or B 11. Training A or B 12. USDF Training or 1st Level Test of your choice

Combined Test: USEF Dressage and Stadium - \$60 each (same dressage tests as HT; circle division and note below)
