Mike Huber is a past member of the United States Equestrian Team. He competed in the 1978 World Games and finished 13th. He was also a member of the 1980 Olympic Team. Mike won the individual gold medal at the 1987 Pan American Games, leading Team USA to a gold medal. He also represented the United States at both the 1990 and 1994 World Equestrian Games. Mike has served as president of the USEA and was an Olympic selector from 1996 to 2000. He was chairman of the USEF Eventing High Performance Committee from 2001 to 2008. In 2009, he rejoined the Olympic selection committee, serving as chairman until 2012. Mike coached the Area V Young Rider Team for 20 years, winning numerous team and individual medals. He is a USEA Level IV ICP Instructor and graduate A pony clubber. In 2015, Mike was inducted into the USEA Eventing Hall of Fame. He currently serves as the chairman of the USEF Eventing Sport Committee. Mike owns and operates Gold Chip Stables in Ocala, Florida.
