Leg bandages permitted in the ring. Riders must wear a hard hat & footwear with heels. Safety vest required for cc. All Cross Country courses for each division will have approximately 15-18 fences. Stadium will be 8 – 10 fences.

- ◆ All entries must be completed in their entirety. ◆ Checks payable to Feather Creek Farm
- ◆ One entry per horse/rider combination. ◆ Payment of Entry Fee and Stabling is due with entry- *not considered an entry without it.* ◆ No entry money returned for rider cancellation of entry, after closing date on the Tuesday before the show. ◆ Show Management reserves the right to change ride times when deemed necessary to facilitate timely completion of the show.
